

Addendum: Dog Parks / Off-Leash Pet Areas

Some of our clients request off-leash activity and play for their dog(s).

For the purposes of this agreement, the pet owner is the responsible person contracting services for one or more domestic pets. Finley's Friends LLC is the pet care company providing care for the client below. Finley's Friends provides services to the pet owner/client below which includes, but is not limited to: off-leash activity.

This agreement is entered into by and between Finley's Friends LLC (service provider) and _____ (Client). Client desires to employ Finley's Friends LLC and its contracted pet professionals to provide pet care and agrees to the terms below:

1. Services

Client is aware and agrees that the Client's dog(s) may be off-leash in designated dog parks and other off-leash legal-for-dogs areas in order to provide maximum exercise and play for the client's dog(s).

2. Health of Pet(s)

Dogs must be vaccinated against Rabies, Distemper, and Bordetella to receive services. Please communicate directly with a pet professional if there is a medical reason for lack of vaccinations. At our request, we may require confirmation from a licensed veterinarian that pet(s) has received all required vaccinations.

3. Injury

Client acknowledges that the highest level of care shall be given to all pets under the care of Finley's Friends LLC and its contracted professionals. Client agrees that should the client's dog(s) run away or be injured during the off-leash time, neither Finley's Friends LLC nor its contracted pet professionals will be held liable for any damages resulting to people, other animals, or to the client's dog(s).

Finley's Friends LLC and its contracted pet professionals will not be responsible for any pet(s) that instigate fights with other animals or is injured by another animal while in Finley's Friends LLC's care. Our pet professionals take all appropriate actions to ensure that the client's pet(s) are not placed in the company of known aggressive or violent animals and will immediately remove the client's pet(s) from any animal fight or otherwise potentially dangerous situation. Clients will be responsible for any and all medical expenses and/or damages resulting from an injury to any person or pet(s) by the client's pet(s), as well as their own pet. Client authorizes Finley's Friends LLC to release the name and contact information of pet parent to any party involved in any incident resulting in injury. Client agrees to indemnify, hold harmless, and defend Finley's Friends LLC in the event of a claim by any person injured by the client's pet(s).

4. Other Pets

The client acknowledges that the pet professionals cannot control other animals within these off-leash spaces. The client confirms that they are aware of the risks and dangers of dog parks and other off-leash legal-for-dog spaces.
